Strategies for Math Placement during COVID 19: A Discussion around Multiple Measures and its Impact on Student and Institutional Success

Bridge Programs that Support Community College Students with Autism

TRACK: Addressing the Needs of Students

Prior postsecondary education research suggests that, despite the capability to achieve a two-year or four-year degree, students with autism spectrum disorders (ASD) are less likely to participate in higher education when compared to their peers with other disabilities (Wei, Yu, Shattuck, McCracken, & Blackorby, 2013). To date, there is little data on student success outcomes specifically for students with ASD even though it is a fast-growing population, with 1 in 54 children currently being diagnosed, according to recent CDC Estimates. Customized programmatic support can help ease the transition within a broad framework that reconceptualizes the problem in terms of strengths and barriers. The current presentation focuses on two pilot programs that fund customized supports during transformational periods for the ASD community college student. The two pilot projects have wide implications for community college administrators, trustees, and faculty members as we seek new strategies to provide effective program supports in promoting the success of students on the autism spectrum.
